#### C. Inhalation

If it is suspected that fumes are still present, the rescuer should wear an appropriate mask or self-contained breathing apparatus. ## B. Appropriate engineering controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits.
