#### D. Ingestion

# B. Specific hazards arising from the chemical

: Highly flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. ### Section 6. Accidental release measures

**Small spill** 

: Stop leak if without risk. Move containers from spill area. Use spark-proof tools and explosion-proof equipment. Dilute with water and mop up if water-soluble. # Section 7. Handling and storage

#### A. Precautions for safe handling

**Protective measures** 

Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing vapour or mist. Avoid release to the environment. Use only with adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Do not enter storage areas and confined spaces unless adequately ventilated. B. Appropriate engineering : Use only with adequate ventilation.
