Description of necessary first aid measures

Eye contact

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Methods and material for containment and cleaning up

Small spill

Precautions for safe handling

Protective measures
