# **Description of necessary first aid measures**

**Eye contact**

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. # For non-emergency personnel

# Methods and material for containment and cleaning up

## **Small spill**

Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

# Large spill

Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see Section 13). # Precautions for safe handling

#### **Protective measures**

# Appropriate engineering controls
