Section 5. Firefighting measures

Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

- Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

In some cases, fume scrubbers, filters or engineering modifications to the process equipment will be necessary to reduce emissions to acceptable levels.

Individual protection measures

Appropriate techniques should be used to remove potentially contaminated clothing. Wash contaminated clothing before reusing. Ensure that eyewash stations and safety showers are close to the workstation location.

- Eye/face protection** : Safety eyewear complying to ISO 16321-1:2022 should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists, gases or dusts. If contact is possible, the following protection should be worn, unless the assessment indicates a higher degree of protection: safety glasses with side-shields.

Skin protection

- Hand protection** : There is no one glove material or combination of materials that will give unlimited resistance to any individual or combination of chemicals.
