Section 4. First aid measures

Description of necessary first aid measures

Section 5. Firefighting measures

Extinguishing media

Specific hazards arising from the chemical : Flammable liquid and vapour. Runoff to sewer may create fire or explosion hazard. Methods and material for containment and cleaning up

Section 7. Handling and storage

Precautions for safe handling

Protective measures : Put on appropriate personal protective equipment (see Section 8). Do not get in eyes or on skin or clothing. Do not breathe vapour or mist. Do not ingest.
