Section 4. First aid measures

Description of necessary first aid measures

Eye contact

Ingestion

Section 7. Handling and storage

Precautions for safe handling

Protective measures

Do not get in eyes or on skin or clothing. Do not breathe vapour or mist. Do not ingest. Avoid release to the environment. Use only with adequate ventilation. Appropriate engineering controls
