Directions for use

Surface preparation

Shake the can before use. For contaminated surfaces dilute the product with water at a ratio of 1:3. For heavily contaminated surfaces, use undiluted product. For plastic windows dilute the product with water at a ratio of 1:20. Apply directly on the surface. Clean the surface using a brush or a sponge. Allow to work 10-15 minutes. Rinse well with fresh water.

Pretreatment

Areas with mould and green algae, use recommended Jotun Yachting products.

Finish coat

Textile Watershield. Refer to TDS, direction for use for the selected Jotun Yachting product.

Remarks

Do not let the product dry on the textile or plastic window.

Storage

The product must be stored in accordance with national regulations. Keep the containers in a dry, cool, well ventilated space and away from sources of heat and ignition. Containers must be kept tightly closed. Handle with care.
